PRE MEETING: Before the usual business of the Policy and Finance Committee, a presentation by

Angela Smith, Green travel consultant was made for the LCWIP (Local cycling and

Walking Infrastructure Plan). The plan was discussed by members.

**21/PF140 Declarations of Interest:** None declared.

**21/PF141** The minutes of the meeting of 4 March were approved to be signed at future physical meeting.

**21/PF142** The Committee received the revised meeting schedule which had been revised to meet external Audit reporting deadline. **ACTION** Revised schedule to be circulated to all Councillors.

**21/PF143** The Committee received a report by the RFO on the Forecast Financial Outturn for the last Financial year ending 31 March 2021. Based on information known at the time of writing there is a forecast underspend against the Annual Budget of £45,000.

21/PF144 The Committee reviewed the statement of Capital expenditure and Revenue reserves RESOLVED to review at the next meeting 10 June 2021. It was discussed that further reserves or capital would be required for the extension of Bicester Road Cemetery. The funds put aside to offset the impact of the Covid 19 restrictions are likely to be reallocated as not needed due to the management of budgets by officers during the past 12 months.

**21/PF145** The Committee received a report from the Chair on the CCLA investments held by the Parish council in Short and longer term funds.

## **RESOLUTIONS TO BE REPORTED TO COUNCIL:**

- 1. The council retain the use of the CCLA deposit fund for short term needs
- 2. The council continue to keep the investment in the property fund and monitor the performance of the fund for long term needs
- 3. The council should decide at the budget setting time if and where the dividends from the CCLA property fund are reinvested.

**21/PF146** The Committee discussed The Meanwhile project and agreed to assist the project by locating and contacting Landlords where known. Any information to be sent to the Clerk, there will be a meeting in four weeks' time.

**21/PF147** Stratfield Brake. The Clerk informed the committee that the transfer was on track for the release of the facility by Parkwood to CDC. Dialogue with the clubs was also going well.
