# **Minutes of the Annual Meeting of Kidlington Parish Council**

held at Exeter Hall and on Zoom at 7.30pm on Thursday 18 May 2023

 The Council RESOLVED to appoint Allison Leigh as Acting Clerk for the meeting. The Council sends their best wishes to Rachel.

- 2. To elect a Chair for 2023-24: David Betts nominated David Robey as Chair. Alan Graham seconded him. The Council **RESOLVED** to elect David Robey as Chair for the coming year. David Robey accepted for one year only.
- 3. To elect a Vice Chair for 2023/24: David Robey proposed Lesley McLean as Vice-Chair. Alison Street seconded her. The Council **RESOLVED** to elect Lesley McLean as Vice-Chair.
- 4. To receive apologies for absence: None
- 5. The Council **RESOLVED** to co-opt Neil Prestidge, David Thurling and Phil Wyse to the Council due to vacancies following the election.
- 6. Declarations of Acceptance of Office were signed by all councillors.
- 7. To receive disclosures of personal and prejudicial interests from Councillors on matters to be considered at the meeting: Cllr Linda Ward reported she has spoken to the Monitoring Officer (MO) as she is a member of Kidlington Development Watch. The MO reported this membership does not preclude Cllr Ward from participating on matters relating to Oxford United Football Club.
- 8. Public Participation a member of the public was in attendance to speak on the issue of the recent Parish Poll.

A resident asked the Council to reconsider its stance of neutrality with regards to Oxford United Football Club's stadium plans. She noted the poll response was significant: out of over 3000 responses, 2073 were against the Football Club coming to Kidlington. She also noted other reasons for which Council should reconsider its stance.

It was agreed to refer to Policy and Finance Committee the possibility of setting up working parties on communications and sports and recreational provision.

- 14. The Council **RESOLVED** to continue to receive the Councillors Allowance (1 voted against and 1 abstained). It was noted that Councillors can choose to opt out and that co-opted Councillors cannot claim.
- 15. To receive Minutes of Committees and consider recommendations:
  - a. Planning Committee on 13 April (minutes on website for review) Cllr Graham moved the minutes of the 13 April and departed the meeting at this time.
  - b. Community Committee on 20 April Cllr Street moved the minutes of 20 April.
    - Coronation Garden It was reported that this is going ahead.
    - Dogs at St Mary's and Stratfield Brake New signage is still being considered. The issue of
      dogs being kept on leads in St Mary's will be looked into with the St Mary's Fields
      committee. Stratfield Brake could do with more signs in relation to dogs. This will be
      followed up with Liam Didcock. The Community Committee will review and then come to
      Council with recommendations.
    - Trees at Ron Groves 3 trees opposite residents' houses have been removed and planted elsewhere. A letter of thanks from a resident had been received.
    - Seating at Lyne Road bus shelter No update.
  - c. Policy and Finance Committee on 27 April Cllr Betts moved the minutes of 27 April.
    - S137 Grants Two grants were made to Cherwell Theatre Company and (subject to further clarification) North Oxfordshire Foodbank.
    - Playing Pitch Strategy.
    - Co-options following elections.
- 16. To review and adopt Statutory Documents:
  - a. Standing Orders The Council **RESOLVED** to adopt the Standing Orders.
  - b. Financial Regulations The Council **RESOLVED** to adopt the Financial Regulations.
  - c. Scheme of Delegation (to be referred to P&F) The Clerk will be creating a draft for P&F.
  - d. Publication Scheme The Council **RESOLVED** to adopt the Publication Scheme.
- 17. To discuss the outcome of the Parish Poll regarding Oxford United Football Club.

  The Parish Council agreed that this was a significant result, although it did not support the calling of the poll. However, for the time being, for the same reasons as before, it **RESOLVED** to remain neutral on the stadium issue until detailed plans for the stadium are available. It was noted that the County Council plans a further consultation with residents and more widely after the detailed plans are available, and could still decide to proceed with the proposal, whatever the Council and residents might think.

It was noted that a position of neutrality is the best one from which to engage with the County Council and the Club on

- Mitigating the potential adverse effects of the development
- Maximizing the potential benefits to residents
- The sustainability of any agreements reached
- Ensuring that the next consultation process is as fair and robust as possible.

It was further agreed that residents should be thanked for turning out to vote, and that a note should be placed on the website inviting further comments from residents.

#### The Council RESOLVED to suspend Standing Orders and extend the time of the meeting.

- 18. To discuss the potential redevelopment of Exeter Close (oral report). David Robey and the Clerk will have a further informal meeting with a developer on this and more reports will be circulated.
- 19. Botley West Solar Farm (oral report). The Council will be sending a letter to the MP with regards to Botley Solar Farm. The Chair had made further enquiries about fire risk, and amended the text of the Council's position accordingly.
- 20. To receive reports from County and District Councillors.
  - a. <u>Cherwell District Council</u>: District councillors reported on the current state of negotiations on the Council leadership.
  - b. **County Council**: Nigel Simpson reported the following:
    - A special education needs review is needed and being worked on.
    - Yellow lines: It is down to the Parish Council to push any new yellow lines needs to the next level as these would be paid for by the Parish Council. Cllr Betts noted that enforcement is an issue as the current lines aren't clear. It was noted that P&F and the Traffic Advisory Committee would need to be involved in this matter.
    - 20mph Speed limit comes into effect on 22<sup>nd</sup> May. It was noted that some signage isn't yet up.
    - There will be a Guide dogs tea party at the Methodist Church on 31st May from 2-4pm.
